1-The tender is required to deposit the earnest money of Rs 10,000(Ten Thousand only) for equipment and Rs 5000 (Five Thousand only) for Chemicals ,Grasswares ,Plastic wares and filter paper ,field material ,Renowned branded Quality Furniture, AMC of UPS & photocopier .EMD should be in form of FDR /Draft in favour of comptroller ,NDUAT Kumarganj Faizabad .

2-Manufacturers are only needed to Quote the rates for these items .

3-The cost of tender form is not refundable .

4-The last date for sale of tender is ~~24.02.13~~ <sup>24.02.13</sup> and the last date for accepting the tender is ~~24.02.13~~ and will be opened on the next day or on any other working day as fixed by Chairman CPC .

After sales service facilities should be indicated in tender if applicable ,Client list and ISO certification , ISI / DGS & D/DI registration if any should be enclosed with Technical bid .

6-The tender must be submitted to store purchase section of NDUAT Kumarganj ,Faizabad through regd./speed post only .University will not have any responsibility for the loss of tender on a/c of postal delay .

7- The delivery of items as per tender specification /make approved shall only be accepted at university Kumarganj Faizabad and on bill basis only.

8-Validity of date of tender should be 31-03-2014 .Part delivery of supply are not accepted for payment .

9-The university reserves the right to reject one or all tender and also reserves the right to place the order for all in full quantity or part there of or not all .

15-The terms and conditions given by the supplier will not be binding on us.


16-Quality assurance certificate will be required from tenderer with technical bid .
