General Terms and Conditions of Tender Notice No. 2/2015-16 (Cost of Tender Rs. 1000+5% VAT for each items)

1-The tenderer is required to deposit the earnest money of Rs 5,000(Five Thousand only) for supply and printing of Poorvanchal kheti,KrishinDiary 2016,Poster etc as per specification. EMD should be in form of FDR /DD only in favor of comptroller ,NDUAT Kumarganj Faizabad .

2. Sample of the papers to be used in printing must be enclosed with the tender.

3-The cost of tender form is not refundable .

4-The last date for sale of tender is 20-2-16 and for accepting the tender is 26-2-16 and will be opened on the next day or on any other working day as fixed by Chairman CPC .

5-The firm must be income tax and cst/vat registered for the concerned business..Copies of the certificate of registration are invariably required .

6-The tender must be submitted to store purchase section of NDUAT Kumarganj ,Faizabad through regd /speed post only .University will not have any responsibility for the loss of tender on a/c of postal delay .

7- The delivery of items as per tender specification /make approved shall only be accepted at university Kumarganj Faizabad and on bill basis only.

8-Validity of date of tender should be 31-03-2016 .Part delivery of supply are not accepted for payment.

9-The university reserves the right to reject one or all tender and also reserves the right to place the order for all in full quantity or part there of or not at all .

10- In case of any dispute the verdict/decision of the Hon'ble vice chancellor of the university shall be final and binding upon both the parties. All legal dispute shall be subject to Faizabad Jurisdiction only .


11-The tender must be submitted in form of Technical bid and financial bid in sealed separate envelopes .and both of them should be kept in third envelop.

12-Earnest money will be for forfeited when the firm does not supply the items with in time or as per required specification . .previous deposited earnest money can not be adjusted.

13- In token of acceptance of above terms and conditions, kindly return this sheet duly signed and sealed .
