

2. Application through Proper Channel: Persons already employed should submit his/her application form "Through Proper Channel" however, to avoid delay they may submit an advance copy of application. Application through proper channel should reach the university within 30 days after the closing date for receipt of applications.

3. Age Limit: For the post of Assistant Professor the age should be 18-40 years as on last date of submission of application form. Relaxation of 05 years is provided to the candidates belonging to OBC, SC,ST and PWD category.

4. Reservation Policy will be followed as per Government of Uttar Pradesh Rules, wherever applicable. The SC/ST/OBC/ EWS /PWD and other candidates are required to attach necessary certificate(s).

5. Candidates claiming benefit of OBC, N.C.L./C.L. and EWS category are required to submit OBC certificate and EWS certificate of current financial year.
